Subject: 40 km/h Speed Limit Changes - Bennett Street, Bondi -

**Rubber Speed Cushions Review**

### **COUNCIL OFFICER'S PROPOSAL:**

That Council:

1. Replaces the rubber speed cushions at 27 Bennett Street, Bondi, with a concrete speed hump.

2. Delegates authority to the Executive Manager, Infrastructure Services, to modify the design should on-site circumstances warrant changes.

### 1. Executive Summary

At its meeting on 16 March 2021, Council resolved to install rubber speed cushions at 27 Bennett Street, Bondi for a trial for 12 months as part of the traffic calming treatments for the 40 km/h limit changes. The speed cushions were installed in late 2021.

The 85%ile traffic speeds on Bennett Street were around 51 km/h prior to the installation of speed cushion.

The 85%ile traffic speeds on Bennett Street after the installation of the speed cushions are around 46 km/h.

The reduction of traffic speed is about 5 km/h.

The 3 April 2023 meeting of the Bondi Heights Precinct requested that 'Council please consider the replacement of the speed hump in Bennett Street so as to be the same type currently in use in Ocean Street or removed altogether'.

The travel lanes in Bennett Street are wide at 3.4 metres with additional clearances to parked cars. This results in some drivers mounting the hump with the passenger side wheels whilst keeping the driver's side wheels off the hump. Higher speeds arise as a result.

Bennett Street is more suited to a speed hump across the entire road due to its wide carriageway. It is recommended that speed cushions are replaced with a concrete speed hump.




Figure 1. Location of speed cushions.




Figure 3. Proposed concrete speed hump.

Figure 1 shows the location of the rubber speed cushions. Figure 2 shows the rubber cushions. Figure 3 shows the proposed concrete speed hump.

Council will need to exercise its delegated functions to implement the proposal.

### 2. Introduction/Background

At its meeting on 16 March 2021, Council resolved to install traffic calming devices in multiple locations within the local government area to reduce the traffic speeds and to achieve self-enforcing 40 km/h speed zone. As part of the resolution, rubber speed cushions were approved to be installed at 27 Bennett Street.

### 3. Technical Analysis

The 85th percentile traffic speeds on Bennett Street were around 51 km/h prior to the installation of speed cushion.

The 85th percentile traffic speeds on Bennett Street after the installation of the speed cushions are around 46 km/h.

The reduction in speeds warrants the use of the speed cushions. Further reductions can be expected if a speed hump were installed.

### 4. Financial Information for Council's Consideration

Funding for the installation of the speed hump will come from future budgets.

That Council:

1. Retains the 20 metre 'No Stopping' zone on the western side of York Road, Bondi Junction, north to the signals at the Waverley Bus Depot entrance.

- 2. Replaces the 50 metre section of the 'No Stopping' zone on the western side of York Road immediately north of the signals at the Depot with a 20 metre 'No Stopping' zone and a 30 metre 'No Stopping 7 am—10 am, Monday to Friday' zone, as shown in Figure 2 of the report.
- 3. Reduces the length of the 'No Stopping' zone on the eastern side of York Road, south of Oxford Street, from 30.5 to 17.5 metres.

### 1. Executive Summary

At its meeting on 15 February 2022, Council resolved to install 'No Stopping' restrictions between proposed signals at Waverley Bus Depot and Oxford Street. 30 metres of the restrictions were subject to a six-month trial. Parking in this section of York Road was previously unrestricted.

The restrictions were associated with the closure of the Oxford Street access to the bus depot and signalisation of the York Road access. 20 metres of 'No Stopping' restrictions were required north of the signals as per Transport for NSW (TfNSW) design requirements. This left 30 metres of parking which was until then unrestricted.

The restrictions were put in place in response to TfNSW concerns that redirected bus movements would adversely affect queuing on York Road northbound back from Oxford Street.

Council officers have conducted inspections for queuing in York Road between the Traffic signals at Waverley Bus Depot and Oxford Street at morning peak hours, morning off-peak hours, afternoon school peak hours and evening peak hours. It was found that the 30 metres of unrestricted parking could be reinstated after the morning peak periods during which there was extensive queuing.

Council officers have also examined traffic conditions southbound where there is currently 30.5 metres of 'No Stopping' restrictions south of the Oxford Street signals. The 30.5 metres was required to allow for 2 lanes of traffic crossing Oxford Street southbound to York Road to merge. This no longer occurs, as TfNSW has modified the southbound approach so that it now has one through lane and one left turn lane. The 'No Stopping' can be reduced by 13 metres to 17.5 metres without affecting traffic flows.



It is recommended that the 32 metre 'No Stopping' restriction on the western side of York Road, 20 metres north of the signals at Waverley Bus Depot is replaced with 'No Stopping, 7 am—10 am, Monday to Friday'. It is also recommended that the 30.5 metre 'No Stopping' on the eastern side of York Road south of Oxford Street is reduced to 17.5 metres. Figure 2 shows the proposal parking restrictions in York Road.

The modification of the 'No Stopping' restrictions will result in gain of parking for 2.5 cars on the eastern side of York Road and 5 to 6 cars on the Western side of York road in hours outside weekday morning peak hours.




Figure 1. Existing 'No Parking' and 'No Stopping' zones.

Figure 1 shows the current restrictions. Figure 2 shows the proposed restrictions.

Council will need to exercise its delegated functions to implement the proposal.

### 2. Introduction/Background

At its meeting on 15 February 2022, Council determined to extend the 20 metre 'No Stopping' restriction on the western side of York Road north of the proposed traffic signals at Waverley Bus Depot by 30 metres on a six-month trial basis.

### 3. Technical Analysis

Council officers conducted site visits at morning peak hours, morning off-peak hours, afternoon school peak hours and evening peak hours.

The north bound lanes in York Road South of Oxford Street are fully saturated in the morning peak hours. Queuing of vehicles during morning peak hours in the left lane north bound extends to about 67 metres south of Oxford Street.

The 30.5 metre 'No Stopping' restriction on the eastern side of York Road South of Oxford Street is no longer required due to TfNSW restricting the southbound movement from the north to 1 lane. 17.5 metres will suffice.

It is recommended that the 20 metre 'No Stopping' restriction on the western side of York Road north to the signal at the Bus Depot is retained and the 30 metres of 'No Stopping' 20 metres north to the signal is replaced with 'No Stopping, 7 am—10 am, Monday to Friday.' It is also recommended that the 30.5 metre 'No Stopping' on the eastern side of York Road south of Oxford Street is reduced to 17.5 metres.

The modification of the 'No Stopping' restrictions will result in gain of 13 metres (2.5 cars) unrestricted parking on the eastern side of York Road and 32 metres (5 to 6 cars) of unrestricted parking on the western side of York Road in hours outside weekday morning peak hours.

The statutory 10 metre 'No Stopping' is not signposted on the eastern side of Evans Street south to Violet Street. Vehicles have been reported parking close to the intersection and causing issues in sight distances.

It is recommended that Council installs a 10 metre 'No Stopping' on the eastern side of Evans Street south of Violet Street. Figure 1 shows the location of the intersection. Figure 2 shows the existing and proposed 'No Stopping' zones.

Council will need to exercise its delegated functions to implement the proposal.

### 2. Introduction/Background

12 metres of 'No Stopping' zone is currently signposted on the eastern side of Evans Street north to Violet Street. The statutory 10 metre 'No Stopping' is not signposted on the eastern side of Evans Street south to Violet Street. Vehicles have been reported parking close to the intersection resulting in sight distances being limited for drivers turning from Violet Street onto Evans Street.

### 3. Technical Analysis

Rule 170 of the *Road Rules 2008* (NSW) states that the statutory 'No Stopping' distance is 10 metres from nearest intersecting road at un-signalised intersections unless a parking control sign applies and the driver is permitted to stop at that place.

It is recommended that a 10 metre 'No Stopping' zone in installed on the eastern side of Evans Street south to Violet Street.

A 17 metre 'No Stopping' restriction at the western side of Sandridge Street, North of Fletcher Street, Bondi is currently delineated by yellow line marking. The yellow line marking has degraded.

This degrading of yellow lines has occurred at various locations around the local government area. In addition, some yellow lines have been painted over by persons unknown in order to justify parking within the No Stopping zone. Repainting of the yellow lines does not resolve these issues. Installation of signage is a more permanent solution.

Council officers propose the installation of an 18.9 metre 'No Stopping' zone at the western side of Sandridge Street, north of Fletcher Street, to provide a more visible and permanent solution to cars parking illegally.

The site location is shown in Figure 1. Figure 2 shows the section of Sandridge Street where the parking restriction is proposed.




Figure 1. Site location.

It is recommended that the existing 5.3 metre 'P Disability Only' zone is extended to 12 metres to accommodate two 6 metre mobility parking spaces. The extended mobility parking space will include the redundant driveway to 20 Philip Street. Figures 1 and 2 show the location of the site and the mobility parking space.

Council will need to exercise its delegated functions to implement the proposal.

- 1. Applicant must have an approved Mobility Parking Scheme Permit.
- 2. Application must be for a vehicle registered to the address.
- 3. Applicant must not have access to off-street parking within their property.
- 4. The level of parking within 50 metres either side and opposite of the property to be surveyed on 2 occasions at random by Council officers. The parking demand is to be above 85% capacity on both occasions.

### 3. Technical Analysis

Compliance of the proposal with Council standard requirements is presented in Table 1. Table 2 presents the surveyed parking demands.

The property has driveway leading to a grassed area which could be used for parking. However, the grassed area would need to be formalised with materials to provide a hardstand area. This is not an option for the applicant.

There is a 5.3 metre mobility parking space in front of the adjoining property. It is recommended that the existing mobility parking space is extended to 12 metres to accommodate two 6 metre mobility parking spaces. The extended mobility parking space will include the redundant driveway to 20 Philip Street.




Figure 3. Dimensions for on-street parking spaces

The proposed length of 6 metres per mobility parking space is based on the typical parallel parking length from the Australian Standard AS2890.5-2020 – On-Street Parking, as shown in Figure 3 below.

The lengths in Figure 3 are not standard lengths for accessible parallel parking spaces. AS2890.6-2009 – Off Street Parking for People with Disabilities contains guidelines for car parking spaces that accommodate for all users with a disability. The dimension for car parking spaces in AS2890.6 are different as they cater for wheelchair access.

AS2890.5-2020 allows the local authority to install mobility parking space to suit the situations. Council has adopted the lengths in Figure 3 in its Guideline to On-Street Mobility Parking Spaces.




Figure 1. Site location.




Figure 3. Dimensions for on-street parking spaces.

  - (a) 2 spaces on the eastern side of Craig Avenue, Vaucluse, east of Diamond Bay Road.
  - (b) 2 spaces on the southern side of Trafalgar Street, Bronte, south of Pembroke Street.
  - (c) 2 spaces on the eastern side of Castlefield Street, Bondi, in front of 15 Castlefield Street.

### 1. Executive Summary

Council has approved the installation of multiple electric vehicles (EV) charging stations at several locations in the Waverley local government area (LGA), as shown in Figure 1. Four stations have been installed. The other four stations will be installed over time.

Figure 1 shows the location of the approved electric vehicle charging stations and proposed signage modification.



The installed stations are currently signposted as 'No Parking, Electric Vehicles Excepted Only While Charging.' The same signage applies to the approved stations still to be installed. Electric vehicles can be plugged in and parked at these stations all day.

Recent changes to the NSW Road Rules added rules in relation to parking at electric vehicle charging stations. The changes allow parking time restrictions to be placed on EV charging stations.

It is recommended that the approved restrictions are added, with '2P, 8 am–6 pm, Electric Vehicles Only While Charging' in metered parking areas and '4P, 8 am–10 pm, Electric Vehicles Only While Charging' in non-metered parking areas.

Council will need to exercise its delegated functions to implement the proposal.
