1. Executive Summary

This report seeks approval of the traffic management plans for established events occurring in the local government area. The 2024 traffic management documents are used as a basis.

Council officers note that the traffic management does not typically have major changes year on year. As such, the 2024 documents provide sufficient detail to guide event traffic management. The traffic management plans and associated traffic guidance schemes will be updated to reflect any minor changes closer to event dates, and which will also include amended times as these are confirmed. They will then be submitted to Transport for NSW and the Police as required for final approval. This approach facilitates a more efficient approval process and enhances officer capacity to focus on the event management with delivery partners. All updated documents will be approved via the relevant and applicable channels.

2. Introduction/Background

As part of Council's focus on building community, several events are held throughout the year to harbour and foster community connection, whilst showing off the best of what Waverley has to offer. The six events detailed in this report are some of the larger events that happen annually. These events are typically unchanged from the year before. As such, the traffic management plans and guidance schemes are also minimally changed.

To streamline the process of approvals for these events, this report has been prepared. The consolidation of approval into one report, with the most recent (2024) traffic management documents, intends to provide sufficient information for the approval of all of these events. It is noted that there may be minor changes to the Traffic Management Plans (TMPs) and Traffic Guidance Schemes (TGSs) for these events, and this report intends to delegate responsibility for the approval of these to the Executive Manager, Infrastructure Services. In practice, minor changes to the TMPs or TGSs in response to on-site needs and via input from partners are made under delegated authority closer to event dates in any case.

This report has been structured so that each individual event reads as a standalone report. Council will need to exercise its delegated functions to implement the proposals.

3. Technical Analysis

ANZAC Day

Summary - ANZAC Day

Council has received an application on behalf of North Bondi RSL Club requesting consideration be given to approving the temporary closure of Ramsgate Avenue and Campbell Parade, North Bondi, to hold an ANZAC Day Dawn Service on Friday 25 April 2025.

The closure and traffic control will be the same as what was implemented for the 2024 ANZAC Day event (see Figure 1).



Figure 1. ANZAC Day closure.

Background - ANZAC Day

The event was last hosted by North Bondi RSL in 2024. Traffic arrangements will be the same as 2024 in 2025. The 2025 Traffic Guidance Schemes (TGS's) are attached to this report. A Traffic Management Plan will be submitted to Transport for NSW and NSW Police for the 2025 event.

This event is a Class 2 Special Event in accordance with the Transport for NSW's *Guide to Traffic and Transport Management for Special Events*.

This event will require an approval from the Transport Management Centre (TMC), as a temporary full closure is proposed. The applicant will be advised to contact the TMC to obtain the required approval.

Technical Analysis – ANZAC Day

The Traffic Management Plan will propose the closure schedule outlined in Table 1.

Bondi Festival

Summary - Bondi Festival

Council is in the planning stages of the annual Bondi Festival to be hosted between Friday, 4 July, and Sunday, 20 July 2025.

Bondi Festival is an annual arts and place activation event hosted in the Bondi Pavilion, Park Drive South and Bondi Park including the Dolphin Court on the southern end of the Pavilion.

Two integral and long-standing components of the event are a temporary outdoor ice rink located at the southernmost end of Park Drive South and a 27 metre Ferris wheel on the Dolphin Court at the southern end of the Pavilion.




Figure 2. Bondi Festival Event location.

There will be 50 parking spaces reallocated during the seven-day bump in and five-day bump out period for the ice rink. This will drop back to 35 parking spaces during the three-week ice rink operation at Park Drive South (see Figure 2). These spaces and associated aisles will be occupied by the ice rink, a generator and a turning area for drivers to make a three-point turn.

Background - Bondi Festival

Bondi Festival is a Council event that is planned and delivered by the Arts and Culture and Events Teams in partnership with the Bondi and Districts Chamber of Commerce.

In 2020, the event merged two standalone Council events, Bondi Feast and Bondi Winter Magic, into one arts and culture and place activation event. The event aims to support local businesses in Bondi Beach by providing entertainment activities for residents and attract visitation during the winter school holidays.

2025 will be the 15th year an ice rink has been installed at Bondi Beach and the seventh year for a Ferris wheel. The combination of these two activities attracts up to 60,000 visitors to Bondi Beach,

providing an opportunity to bring the community together, economic benefit to businesses and revenue for Council.

The Events team, in consultation with Traffic, Open Spaces, Major Projects, Parking, and Infrastructure Services has previously considered several locations for both activities.

Key guiding considerations for identifying locations were risk and safety, minimising disruptions to park operations and park users, ensuring access to three-phase power and the need to bring all Festival activities together in one central Festival hub, ideally focussed near local businesses.

Technical Analysis - Bondi Festival

Alternative location investigations

The following alternative locations have been previously assessed for the Ferris wheel and ice rink. For a range of reasons, however, no other locations are suitable:

- North Bondi Park. This location has level ground to accommodate the ice rink but it is too far
 from the Festival hub and has no access to three-phase power. Major damage to the park
 would also occur. The Ferris wheel is not an option here; the trucks that transport the wheel
 are too large to enter this area of park.
- Bondi Park (between Hall and Roscoe Street). The ice rink was in a section of this park several years ago. The sloped gradient of the park created considerable site challenges. It also resulted in damages to the grass and irrigation lines. The same gradient and damage issues apply to the Ferris wheel. A small flat section of Bondi Park near the Campbell Parade bus stop between Hall and Roscoe Street was considered for the Ferris wheel. It was ruled out due to risks related to privacy for residents on the other side of Campbell Parade and potential traffic issues for motorists.
- South Bondi Park. This location presents the same issues as Bondi Park regarding gradient and damages. It is also too far from the Festival hub and has no access to three-phase power.
- Bondi Beach Promenade. A potential location on the promenade next to the Skate Park was
 identified as a possible location for the Ferris wheel. However, it is too far from the Festival
 hub, has no access to three-phase power and it is uncertain whether the required trucks
 would have space to build the wheel without requiring a multi-day Promenade closure.

These factors leave Park Drive South as the only suitable location for the ice rink, and the Dolphin Court as the only suitable location for the Ferris wheel.

This event does not have any traffic management, as there is no impact or restriction to through travel. The closure and parking changes in Park Drive South are enacted by Council's Events Team. As such, there are no attachments to show TGSs or TMPs in this instance.

City2Surf

Summary - City2Surf

As per previous years, Council will receive an application to temporarily close several roads in the Waverley local government area to conduct the 2025 City2Surf event. This is an annual event.

The event will take place on Sunday, 10 August 2025. The 2024 Transport Management Plan (TMP) is attached for Council's consideration (see Attachment 5).

Background - City2Surf

City2Surf has transformed from a local road race into one of the world's largest fun run events that attract Sydneysiders, along with thousands of participants from across the country and around the world.

The 14 km course runs from Hyde Park to end at Bondi Beach. The event raises money for charity through ticket sales for runners and sponsors.

This is an annual event.

Technical Analysis - City2Surf




Figure 3. City2Surf Special event clearways and road closures

Figure 3 shows the location of special event clearways and road closures across the event area for the 2024 event.

The attachments prepared by Transport for NSW (Attachments 4, 5, and 6) provide an overview of the key traffic and transport-related elements of the event across the event area.

Local access and course crossing points

Access for residents to cross the course will be maintained at the locations below. Once the course is locked down, there will be no access until roads reopen. The times below are indicatively based on 2024 timing and will be finalised closer to the event date as the broader event times are finalised. Applicable to the Waverley local government area are the following:

- North Bondi: Brighton Boulevard and Ramsgate Avenue one-way exit only until 7 am. No entry after 6 am.
- Bondi Road will be heavily congested with hundreds of buses transporting thousands of participants between the beach and Bondi Junction. Residents are urged to avoid unnecessary
 travel on Bondi Road.
- Residents north of Bondi Road should use Old South Head Road to enter or exit the area.
 Residents south of Bondi Road should use Birrell Street.
- Local access for residents at Bondi Beach will be maintained via Curlewis, Gould and Hall Streets—No exit onto Lamrock Avenue.

Special Event Clearways

Special Event Clearways are 'No Stopping' zones for all vehicle types. They will be in effect on both sides of the entire 14 km course. The times below are indicatively based on 2024 timing and will be finalised closer to the event date as the broader event times are finalised. Affected roads are:

- Rose Bay to Bondi from 1 am to 4 pm: New South Head Road, Military Road, Campbell Parade, Old South Head Road and local streets at Bondi Beach including Hall Street, Lamrock Avenue, Curlewis Street and other nearby roads.
- The Medland-Bamford Ramp and along Warners Avenue (adjacent to Barracluff Reserve)—To be utilised as towing compounds.
- O'Sullivan Road from Latimer Road to New South Head Road and a section of Warners Avenue from 4 pm Saturday, 9 August, to 4 pm Sunday, 10 August.

This is a Hallmark Class 1 Special Event, with road closures implemented under Transport for NSW's (TfNSW) *Guide to Traffic and Transport Management for Special Events*. The Traffic Committee is required to make recommendations to Council regarding the traffic management aspects of the event and advise Council on conditions to set for the use of the road space. Council will then consider these recommendations and assess all other impacts on the surrounding environment before issuing a schedule of conditions.

Road closures

The road closures will require approval from TfNSW. Once all approvals and conditions have been met, staff from TfNSW and Council can approve the TMP to authorise implementation. The proposed road closures and clearways are shown in the attached Traffic Guidance Schemes (TGS's) from 2024.

Council officers have not received any major objections from residents at previous events (the last event was in 2024). Participant cut-off points will be implemented to ensure roads will be opened at specified times.

Festival of the Winds

Summary - Festival of the Winds

A TMP will be prepared for the Festival of the Winds event to be held at Bondi Beach and Bondi Park on Sunday, 14 September 2025. Traffic planning will be in line with 2024 arrangements.

This is an annual event. The event also relies on TfNSW to approve associated clearways on Bondi Road, Campbell Parade and the first block of Hall Street (on both sides of the road from Campbell Parade to Gould Street).

Background - Festival of the Winds

The Festival of the Winds is a free community event held in Bondi Park and Beach featuring professional kite flying displays, kite making workshops, entertainment, and food stalls. The event has experienced a high level of continued growth and now attracts 70,000+ visitors.

The event has a significant impact on transport and traffic networks both within the immediate vicinity of the event and the wider Waverley community.

Transdev John Holland Buses will provide increased bus services to accommodate the increased inflow and outflow of patrons attending the event. Sydney Trains will also provide additional train services to Bondi Junction.

Special Event Clearways – Festival of the Winds

This is a Class 2 Special Event under the TfNSW's *Guide to Traffic and Transport Management for Special Events*. Special Event Clearways will operate from 7 am to 7 pm on:

- Bondi Road, Eastbound between Council and Sandridge Streets.
- Bondi Road, Westbound between Sandridge and Council Streets.
- Hall Street, Eastbound between Gould Street and Campbell Parade.
- Hall Street, Westbound between Gould Street and Campbell Parade.

In addition, Special Event Clearways (authorised route buses excepted) will operate from 7 am until 7 pm on:

- Campbell Parade, Southbound between the exit from Queen Elizabeth Drive and the entrance to Queen Elizabeth Drive
- Campbell Parade, Northbound between Hall and Roscoe Streets
- Curlewis Street, Eastbound between Gould Street and Campbell parade

Road closures - Bondi Beach

A partial closure of Queen Elizabeth Drive (5 am-7 pm) is proposed due to high pedestrian movements conflicting with vehicular traffic. Park Drive (South) parking area will be closed at Beach Road and Campbell parade (to non-event vehicles) from 5 am-7 pm.

A contingency road closure (residents and TransDev John Holland buses excepted) will be in place on Curlewis Street at Glenayr Avenue due to the loss of a turning lane on Curlewis Street roadworks due to the new Curlewis Street cycleway and the potential impact on event bus services. It is not envisaged, however, that this will be required.

Road closures – Bondi Junction

Road closures (buses excepted) are also proposed for Bondi Junction from 10am to 6pm on Oxford St (from Adelaide Street to Grosvenor Street), Grosvenor Street (from Spring to Grafton Streets), Grosvenor Lane (From Newland Street to Grosvenor Street) and Grafton Street (westbound) from Newland Street to Grosvenor Street.

Technical Analysis - Festival of the Winds

The attached TCPs propose the event be undertaken in the manner detailed in Table 2.

Sculpture by the Sea

Summary - Sculpture by the Sea

Sculpture by the Sea 2025 is a free sculpture exhibition held between Notts Avenue and Tamarama Park along the Coastal Walk. The exhibition is planned to be held between Friday, 17 October, and Monday, 3 November 2025. The event is organised by the not-for-profit Sculpture by the Sea Incorporated (referred to in this report as the Event Organiser). To manage the impact of the event on local roads and resident amenity, Council implements a Transport Management Plan submitted to the Traffic Committee for input. This report details the traffic management aspects of the event.

Background - Sculpture by the Sea

Council's Infrastructure Services Department developed the attached Transport Management Plan for last year's event in consultation with the Event Organiser and Council's Events Team. In line with the 2024 event, Council will engage a contract traffic management company to implement the TMP in 2025.

This is a Class 2 Special Event, with road closures, under the Transport for NSW's (TfNSW) *Guide to Traffic and Transport Management for Special Events*.

TfNSW will need to approve temporary closures and one-way movements and the Transport Management Plan will be forwarded to TfNSW for consideration.

Note that a pedestrian deviation will be in place to manage the impacts of the Coast Walk collapse on pedestrian volumes during the exhibition period. This was also implemented in 2024. This does not form part of the traffic and transport management arrangements for the purposes of this report, but is noted here.

Technical Analysis - Sculpture by the Sea

The Sculpture by the Sea Transport Management Plan 2024 Traffic Guidance Schemes are attached to this report. Also attached is a traffic location overview for 2024.

Financial Information - Sculpture by the Sea

Sculpture by the Sea is funded through sponsorship, government grants, philanthropy donations, commission from the sale of sculptures, brochure sales and visitor donations. Council is a major supporter and is recognised as a 'Significant Partner' of the event through the services and funding provided, including the provision of:

- The venue at no charge.
- Traffic management.
- Additional waste collections.
- Parking facilities.
- Park restoration.
- Electricity.
- Additional Ranger and Parks staff hours.
- Other Council officers' time.
- An annual community grant.

These costs are absorbed by the existing budgets of relevant departments.

It is intended that:

- The cost of providing traffic control for the event will be funded by Council from existing budgets
- The cost of providing traffic control for the bump-in and bump-out will be covered by the Event Organiser.

Dudley Page Reserve - New Year's Eve (NYE)

Summary - Dudley Page NYE

The Dudley Page NYE event is an annual event that was last held in 2024.




Figure 4. Dudley Page NYE Event location.

Council prepared a Traffic Management Plan (TMP) for the New Year's event to be held at Dudley Page Reserve on 31 December 2024 (see Figure 4 for the location of this event). The TMP for 2025 will be the same as to the 2024 event, with Military Road again remaining open. Temporary event clearways will remain in place along Military Road to ensure traffic flow and access for buses.

Background – Dudley Page NYE

New Year's Eve celebration at Dudley Page Reserve is an annual event that attracts more than 2,500 visitors. Every year, Council officers prepare a TMP that outlines the traffic arrangements proposed to manage traffic during the event hours.

Technical Analysis - Dudley Page NYE

The attached TMP proposes that road closures and clearways are undertaken at the locations shown in Table 3.

As per 2024, a contingency plan on Portland Street to manage the passage of 323 bus services will be in place and ready to activate. Implementation of this was not, however, required in 2024.

High Holy Days (Bon Accord Avenue)

Summary – High Holy Days (Bon Accord Avenue)

As per previous years, Council will receive an application from the Central Synagogue requesting the temporary closure of Bon Accord Avenue, Bondi Junction, from Bon Accord Lane to Flood Lane, to facilitate the annual High Holy Days celebrations.

Background - High Holy Days (Bon Accord Avenue)

The Central Synagogue has requested approval for the closure of Bon Accord Avenue in the section between Bon Accord Lane and Flood Lane during early October 2025. Exact dates and times are to be confirmed; however, based on initial discussions the closures are expected to be in place Friday and Saturday evenings in late November and early October (see table below).

There are no major changes to partial road closure points to those approved in past years, and only minor changes to the time periods. Council prepared a Transport Management Plan (TMP) and Traffic Guidance Scheme (TGS) in 2024 on behalf of the synagogue (see attachments 18 and 19). The applicant will be undertaking resident notification and submitting the TMP to Transport for NSW (TfNSW).

This is a Class 2 Special Event, with road closures being carried out in accordance with the TfNSW Guide to Traffic and Transport Management for Special Events.

Technical Analysis – High Holy Days (Bon Accord Avenue)

Table 4 outlines the way the closure is expected to follow. The times are indicative and based on last year's closures. The provided TMP outlines the closure in 2024.

TfNSW will need to approve the temporary partial closure of part of Bon Accord Avenue with the TMP being forwarded for the authority's consideration, as the closure may affect Old South Head Road, which is a State Road.

Access for residents and visitors

Access for residents and visitors must be retained at all times. Residents and visitors needing access to properties along the route will be able to do so.

Impacts on Old South Head Road shared path

There is a shared path along Old South Head Road north and south of Bon Accord Avenue. Jersey kerb barriers have been placed on the edge of this shared path and on either side of Bon Accord Avenue at Old South Head Road in past years. These barriers must leave sufficient width for the shared path to serve its function. The minimum desirable width is 2.5 metres. It is considered acceptable that this is reduced to 2 metres for the duration of the event to allow the placement of the barriers.

The Jersey kerbs are in place for the entire period of the four events plus bump-in and bump-out days prior and post-event. Council officers will coordinate to minimise the potential issues that may arise from temporary pinch-points.

There should be no blocking of pedestrian movements across Bon Accord Avenue at Old South Head Road.

Additional conditions

In accordance with the TMP and TGS attached to the report, which is expected to be consistent with the updated 2025 versions, the following conditions apply:

- The Event Organiser must:
 - Engage a traffic control company approved by the Executive Manager, Infrastructure Services, to implement the TMP.
 - Facilitate access to residential properties affected by barriers for residents and visitors.
 - o Provide public liability insurance for the event.
 - Obtain NSW Police approval.
 - Submit the TMP to Transport for NSW for approval by the Transport Management Centre.
 - Notify affected residents as shown in Figure 1 of the supplied Transport Management Plan (Attachment 18).
 - Provide a pre- and post-dilapidation report of the condition of footpaths and landscaping along the section of Old South Head Road and Bon Accord Avenue affected by the event.
- Council may issue a schedule of conditions with any additional conditions that may be imposed by the NSW Police, TfNSW and the Executive Manager, Infrastructure Services.

Financial Information – High Holy Days (Bond Accord Avenue)

The Central Synagogue will be required to cover all associated costs prior to partial closures taking place.

That the Committee notes the items approved from August to December 2024 under the Temporary Instrument of Delegation and Authorisation for Traffic Management and Pedestrian Works, as set out in the report.

1. **Executive Summary**

The purpose of this report is to notify the Waverley Traffic Committee and the public of items that have recently been carried out under Council's Temporary Sub-Delegations. A total of 31 items were approved through the temporary sub-delegation from August to December of 2024, including 18 construction zones, 6 mobility parking space changes, and 7 other items related to minor parking and kerbside regulatory changes.

2. Introduction/Background

In December 2023, Transport for NSW (TfNSW) issued the Temporary Instrument of Delegation and Authorisation for Traffic Management and Pedestrian Works. The Temporary Delegation will be in force until 30 June 2026, unless otherwise revised by TfNSW. On 21 May 2024, Council sub-delegated the functions in the instrument to the General Manager and the Director, Assets and Operations, on a trial basis until 30 June 2026.

The sub-delegation facilitates more efficient implementation of routine operational items. This results in fewer items requiring Traffic Committee input. The focus of ongoing Traffic Committee meetings will be on items that are not included in the temporary delegation, as well as those of a more complex nature or otherwise deemed appropriate for Traffic Committee review. This optimises voting member, participant and Council officer time.

All items that are approved under the temporary sub-delegation must be presented to the Traffic Committee post-approval or implementation, in accordance with schedule 4 item 10 of the instrument. As such, the purpose of this report is to notify the Traffic Committee, Council and the public of items approved under the temporary sub-delegation in Part 2 of the Traffic Committee agenda.

3. **Technical Analysis**

The items presented in Table 1 below are those approved under the temporary sub-delegation. This means that they have or will be implemented in due course. In some cases, the ultimate timing for

implementation is dependent on applicants or external parties (e.g. construction zones) and occasionally may not eventuate at all.
